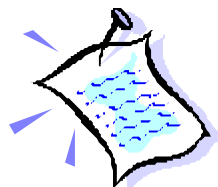

WRITING COMPETITIONS

Note: Throughout the academic year we receive announcements regarding essay competitions and invitations to submit papers for publication in law reviews and journals. This information is posted on the bulletin board in OCS, as well as in OCS Resources for Students in Blackboard under Writing Competitions. In addition to the intellectual and often monetary benefits of these contests, the competitions are another way for you to demonstrate your legal writing abilities to prospective employers. Because they are often sponsored by bar associations and other professional groups, they also provide excellent networking opportunities. Keep in mind that faculty members are a good source of ideas and guidance.

The **Daniel T. Murphy Student Writing Competition**, sponsored by the University of Richmond's *Richmond Journal of Global Law and Business* is intended to foster knowledge and scholarly work by students on specific areas of the Law of the World Trade Organization (WTO). The topic of this year's competition is WTO Treatment of Developed and Developing Countries. The first place cash award is \$500 and publication in the *Richmond Journal of Global Law and Business's* Annual Survey of the Law of the WTO; second place is \$200 and third place is \$100.
